Dear Professor Antokhina,

Thank you for your letter dated 26 March 2020 addressed to Ms Stefania Giannini, the Assistant Director-General for Education, by which you request the renewal of the Agreement between UNESCO and Saint Petersburg State University of Aerospace Instrumentation, concerning the UNESCO Chair on Distance Education in Engineering established in April 1999.

In light of the very good results achieved by the above-mentioned Chair, confirmed by the positive evaluation of its activities, I am pleased to inform you that UNESCO agrees to renew the above-mentioned Agreement for an additional period of four years, until 1<sup>st</sup> April 2024.

I am confident that the UNESCO Chair will continue to work closely with UNESCO Secretariat, its Institutes and other stakeholders in the field of distance education in engineering, and to contribute to the 2030 Agenda for Sustainable Development, notably by strengthening sustainable, inclusive and diversified development of ICTs in Education through training, innovative research projects, documentation and dissemination of knowledge at national, regional and global levels. The Chair is encouraged to reinforce its partnership with some new higher education institutions worldwide and to set up a Network of UNESCO Chairs on ICT in education and teachers training for SDG4.

This UNESCO Chair is renewed for a period of four years. Should the University wish to pursue the activities of the Chair beyond this renewed period, a formal request to renew the validity of the Agreement must be addressed to UNESCO six months before the expiry date of the current Agreement. The decision to renew a Chair's Agreement is based, among others, on the positive evaluation of the reports on the activities carried out by the Chair.

The progress report is due two years after the renewal of the Agreement, followed by a final report two years later. Reports should follow the UNESCO template available at <http://www.unesco.org/en/university-twinning-and-networking/application-and-forms/progress-report-form/>.
